

**TOWN OF GLOVER, VERMONT
SELECT BOARD MEETING
GLOVER MUNICIPAL BUILDING
JUNE 18, 2009**

1. Jason called the meeting to order at 6:33 p.m.
2. Dorothy Mudgett's fence was damaged during the sewer project. Twin State Site Work has removed the fence and they plan on replacing it. The fence was in the town right of way, and the select board would like the new fence out of the right of way to prevent any snow damage from the plow. Mrs. Mudgett asked if the fence could be put back where it originally was, as the snow never damaged it. The select board said it could go back there, as long as she understands that the town is not responsible for any damage done by town equipment.
3. The sewer project is nearing completion. Jason talked to Jeff Currier and Tara talked to Bob Bean to see if they want to be connected to sewer service. Jeff will let the board know soon and Bob would like more information before he decides. Tara will contact Bob with the information he is looking for.
4. The town received a response to the Solid Waste Implementation Plan (SWIP) that Jason and Tara revised in February. It seems to contain the information the state is looking for; however the new information needs to actually be included into the SWIP document. When Tara and Jason sent in the revisions, they sent them in as attachments. Tara will see if Nick Ecker-Racz has an electronic copy of the document, as he drafted the original copy.
5. Pike Industries spoke to Harvey Dunbar about the County Road project. Tar prices are going to increase in July, so Pike could work on County Road sooner than planned. The contract does state that Pike reserves the right to adjust prices. The select board decided to proceed with County Road now and continue with Dexter Mountain Road as soon as possible.
6. There was a discussion about town owned trails. Norman Auger said he would like to be sure the trail that connects his property to Frank Medor's remains a town trail. Bucky is going to look into this as well as the old road near Robert Tetrault's.

7. The select board reviewed the water quality report from Environmental Products and Services in regards to the old tanks that were removed from the Ambulance Bay lot. According to the report, petroleum and lead levels have decreased.
8. The board reviewed a brochure from a company that provides sewer maintenance services. Gary Leach is looking into this further.
9. Jason signed an excess weight permit for J.P. Sicard, Inc.
10. Orders were signed.
11. Minutes were approved.
12. Jason made a motion to adjourn at 8:04 p.m.

The select board will post the next meeting date, as they may continue meeting on Thursdays. This will be posted soon.
