

**TOWN OF GLOVER, VERMONT
MUNICIPAL PARKS, BEACHES, AND FORESTS
ORDINANCE**

SECTION I. PURPOSE.

This Ordinance is adopted under VSA Title 24, Chapter 59, Section 1971. The purpose of this Ordinance is to regulate the hours of operation, parking facilities, the use of open fires and the types of allowable beverage containers which may be used at the municipal parks, beaches, and forests of Glover, VT.

SECTION II. APPLICABILITY OF ORDINANCE.

The terms of the Ordinance apply to all residents and non-residents of the Town of Glover, while physically present on any municipal park, beach, or forest, whether merely in transit or there for the purpose of bathing, hiking, camping, picnicking, or other recreational activity.

SECTION III. REQUIREMENT OF ORDINANCE.

1. All municipal beaches, parks and forests are closed to public use between the hours of midnight and six a.m., unless a specific exception has been made by the Selectmen, with appropriate public notice and warning as to same.
2. No glass containers of any kind will be allowed within the legal property limits of the municipal parks, forests, and beaches of the Town of Glover. Littering is forbidden.
3. Open campfires, cooking fires, or other fires of any kind are prohibited except in such fireplaces as the Town of Glover provides at its beaches, parks, and forests. Portable hibachis, charcoal stoves, or other cooking stoves using petroleum or non-petroleum fuel are allowed. Refuse from fires and stoves must be removed from the municipal land, or disposed of in designated refuse containers.
4. Motor vehicles operated by persons using the municipal parks, beaches, or forests of the Town of Glover must be parked in designated municipal parking spaces, or on private property (with the permission of the property owner). No vehicle may be parked on the travelled portion of any town highway.

SECTION IV. ENFORCEMENT.

The terms of this Ordinance shall be enforced by the Town Constable or his deputy, or any other police officer who has jurisdiction in the Town of Glover. A person who refuses or neglects to comply with the provisions of this Ordinance, or who hinders or attempts to hinder the legal activities of the Town Constable or any other legal law enforcement officer enforcing the terms of this Ordinance, may be fined for each offense, an amount not to exceed \$500 by the Superior Court.

AMENDMENT

SECTION I. PURPOSE OF AMENDMENT:

The purpose of this amendment is to change the time that the Municipal Parks, Beaches, and Forests are closed to public use. To also include the Beach Parking Lot, across the road from the beach.

SECTION II. PURPOSE:

This Ordinance is adopted under VSA Title 24, Chapter 59, Section 1971. The purpose if this Ordinance is to regulate the hours of operation, parking facilities, the use of open fires and the types of allowable beverage containers which may be used at the Municipal Parks, Beaches, and Forests of Glover, VT.

SECTION III. APPLICABILITY OF ORDINANCE:

2. No glass containers of any kind will be allowed within the legal property limits of the Municipal Parks, Beaches, and Forests, including the Beach Parking Lot, of the Town of Glover. Littering is forbidden.
3. Open campfires, cooking fires, or other fires of any kind are prohibited except in such fireplaces as the Town of Glover provides at its parks, beaches, beach parking lot and forests. Portable hibachis, charcoal stoves, or other cooking stoves using petroleum or non-petroleum fuel are allowed. Refuse from fires and stoves must be removed from the municipal land, or disposed of in designated refuse containers.
4. Motor vehicles operated by persons using the Municipal Parks, Beaches, or Forests of the Town of Glover must be parked in designated municipal parking spaces, or on private property (with the permission of the property owner). No vehicle may be parked on the travelled portion of any town highway.

SECTION V. ENFORCEMENT:

The terms of this Ordinance shall be enforced by the Town Constable or his deputy, or any other police officer who has jurisdiction in the Town of Glover. of this Ordinance, may be fined for each offense, an amount not to exceed \$500 by the Superior Court.
