## Quick recap

## Summary

### Call to Order

The meeting was called to order. The group discussed the agenda and reviewed the open meeting rules including confirmation that 100% virtual meetings are allowed for “advisory boards” but that future DRB meetings will be “non-advisory” and will require a physical presence to comply with the rules. A hybrid meeting is allowed. Also noted was the duty to post draft meeting minutes within 5 business days of the meeting.

### Approval of Minutes

The meeting began with the review of minutes from 2/24/2026 and 3/12/2026  
A spelling mistake was corrected, and the minutes were approved as presented.

### Glover Planning Commission Membership

The Commission reaffirmed its membership, confirming nine voting members and one non-voting, ex-officio member. James and Nella were reappointed as co-chairs and also appointed as co-clerks. The motion was made and the motion carried. The Membership is listed below:

All members except Steve Lowe were presented to the Glover Selectboard at the March 12th Selectboard meeting. All members including Steve Lowe will be recommended to the Selectboard at the April 9th Selectboard meeting.

## **Development Review Board (DRB) Formation**

A motion was made to recommend all 9 voting planning members be appointed to serve as the DRB. The motion carried. Jack Sumber explained his role as the Flood Hazard Area and River Corridor Administrator and the DRB's role in reviewing development permits in the Flood Hazard Area and River Corridor that were to complicated for an administrative decision, required by the bylaws to be approved by the DRB or to review appeals of the Administrator's decisions. Appeals of the DRB's decisions would go to the State of Vermont Environmental Court. There was also discussion clarifying that the Selectboard do not have the authority to appeal the DRB's decisions unless they are the applicant on behalf of municipal property.

## **Town Plan Updates**

Members discussed simplifying and condensing the town plan while aligning it with the upcoming NVDA regional template. They also considered integrating an equity framework asking "who is helped, harmed, or missed" by planning decisions. The team reviewed assignment of town plan sections and proposed a schedule of reviewing 4 draft sections per month to review all 16 sections by August. The first sections to be reviewed will be land use, neighboring communities, aging, and housing.

## **Glover Green Project**

The commission decided to postpone discussions with the Selectboard until April 9<sup>th</sup> to allow more preparation. They reviewed easement responsibilities, driveway access, and maintenance costs. James will draft "letters of understanding" to review with the Commission and then with Ray and Sylvia. The discussion circled around the cost of existing lawn maintenance and projected maintenance costs. The group agreed to seek professional maintenance quotes and to get advice on maintenance requirements for the proposed plantings.

The Commission supported Olivia's poster project for public engagement and discussed holding a public outreach meeting for neighbors and citizens. They discussed the general issue of parking and traffic safety in Glover and suggested inviting VTrans to a future meeting to discuss issues and options.
