

**TOWN OF GLOVER
CEMETERY COMMISSIONERS
MEETING MINUTES
Thursday, June 2, 2022
Glover Municipal Building – 7:30am**

Present: Joan Alexander, Ricky Blanchard, Theresa Perron, Jessica Sweeney, and Cindy Epinette, Assistant Sexton.

1. The meeting was called to order at 7:30am.
2. **Approval of Minutes:** Jessica made a motion, seconded by Joan to approve the minutes dated April 5, 2022 as presented. The motion carried.
3. **Financial Update:** Cindy distributed the trail balance figures through 6/3/22. It was noted that revenues from the appeal letter donations and donations in memory of Edwin Alexander total \$8,268 and the \$17,000 from the general fund has been transferred into the cemetery banks accounts. Everything is looking good.
4. **Discussion/Approval of Draft Rules & Regulations that include Green/Natural Burials and the memorial Garden:** A draft of the Rules and Regulations to include Green/Natural Burials and the Memorial Garden were reviewed. Fees for the Memorial Garden are on hold pending information from Heritage Memorial for a granite marker. It was decided to exclude stating rates for Jonathan Perkins services. Jonathan's fees are subject to change and not controlled by the town. Cindy will contact local cemeteries to see what they charge for a memorial garden space, green/natural burial lot and to open/close a lot.
5. **Planning for Memorial Garden:** Two options for a Memorial Garden were discussed. The Committee decided to go with a single path that winds through the garden. Joan and Cindy met with Michael Pray, Road Foreman, and there are several boulders set aside for the Memorial Garden.
6. **Inventory of stone repair work/other needed at each Cemetery this summer:** Joan has created a list of stones that need to be repaired. This will be discussed at a future meeting.
7. **Report of Westlook Terrace lot checking done by Cindy and Joan:** to be discussed at another meeting.
8. **Replacing front fence missing sections at Westlook I:** Cindy has called Round Hill Fence company to get an estimate of the cost to replace the broken fence. She has not received the estimate at this time.
9. **Plans for June 29 (7pm) community informational meeting re: Natural Burial and Memorial Garden at Westlook II:** Another meeting will be held on June 14th at 7:30am to make plans for the informational meeting. A notice will be placed in the Chronicle, Front Porch Forum, Facebook and on the website to welcome people to attend.
10. **Replacing sides and back fencing at all 4 cemeteries:** postponed to a future meeting.
11. **Reaching out to potential high school community service workers:** postponed to a future meeting. Joan will speak with the Glover 8th graders on June 6th. The electronic display at Lake Region has advertised work is available for those interested. One student has expressed interest in working for the cemetery over the summer and there are two more students who may be interested as well.

12. **Community Cleaning Gravestone Workbee: Andersonville July 16th, 9am-11am:**
postponed to a future meeting.
13. **Cemetery Walks this summer, each on Saturday: Westlook July 9th at 1:30pm; July 16th at 11am; July 30th at 4pm; West Glover August 20th at 10:30am.**
14. **Other:** none.
15. **Adjourn:** The meeting adjourned at 10:30am.


