

TOWN OF GLOVER
CEMETERY COMMISSIONERS
MEETING MINUTES
Wednesday, September 14, 2022
Glover Municipal Building – 7:00pm

Present: Joan Alexander, Theresa Perron-Janowski and Cindy Epinette, Assistant Sexton.
Absent: Ricky Blanchard and Jessica Sweeney

1. There was no quorum at 7pm.
2. The meeting was called to order at 7:30pm.
3. **Approval of past meeting minutes:** postponed until the next meeting
4. **Final approval of Rules & Regulations:** postponed until the next meeting
5. **Financial Report:** postponed until the next meeting. Cindy indicated there was \$17,000 in the checking account, \$3,500 in the PC account, \$1,500 in the improvement account, \$66,000 in the reserve account and \$4,000 in the stone repair account.
6. **Update on Westlook I front fence repair:** Round Hill Fence and Security have been contacted to repair the fence. There is no date set as to when it will be repaired, at this time.
7. **Sides and back fence replacement for all cemeteries:** Researching and scheduling this work will be postponed until next year.
8. **Eagle Scout project at Andersonville update:** There are two young men who would like to do an Eagle Scout project in the Glover cemeteries. Aiden Blanchard will undertake the repainting of the metal fence. Garrett Perron is reviewing possible projects. Joan has accumulated several suggestions and will present these suggestions to Garrett. The suggestions include building kiosks for one or more cemeteries and replacing the fence around one or more cemeteries.
9. **Green Burial plans update:** Joan is meeting with Curtis-Britch on Thursday to receive an update on what green services they will offer folks and ask questions about winter burial options.
10. **Memorial Garden update:** Kate Butler has indicated it will cost \$2,500 for the mulch in the memorial garden area. Theresa will speak to her about getting a quote/estimate for her services. It was suggested that the memorial garden be completed in sections, for example the mulch and boulders be placed this year, then the walk-ways and edging be placed next year, then the trees and granite stone be placed the following year.
11. **Stone repair work by Heritage this fall? Do we have money for it and do they have time?** Joan has not contacted Heritage about which grave stones need to be replaced/repared. It was decided to not have any stones repaired/replaced this year.
12. **Other:** ARPA Funds: The Commissioners would like to submit a request for financial assistance for the memorial garden project. Once Theresa acquires the quote from Kate with more detail of what it will cost, Cindy will create the application.
13. **The meeting adjourned at 8:30pm.**
